

SWGG120 Instructions

- 1. Stun Contact Probes
- 2. LED Flashlight
- 3. Test Probes
- 4. Grab Guard Stun Strips
- 5. Stun Trigger
- 6. Charging Indicator Light
- 7. Safety/Function Switch: (Off • Light / Alarm • Stun)
- 8. Stun Warning Light
- 9. Charging Port
- 10. Wrist Strap





CHARGING THE BATTERIES

- 1. The rechargeable batteries are already installed. The unit cannot be opened, as this will void the warranty.
- 2. Before use, the stun gun will need to be charged for 3-4 hours.
- Using the included USB charging cord, plug the mini-USB end into the charging port on the stun gun (#9) and the other end into your USB charging device (computer, wall or block charger, or car plug). The Battery Indicator Lights (#6) will flash while charging. Four solid lights indicate a full charge.

USING THE FLASHLIGHT

- Slide the Safety/Function (#7) Switch (located on the side of the unit) up to the middle position to turn on the LED Flashlight.
 Pressing or holding the Stun Trigger (#5) in this mode will activate the alarm
- 2. Slide the Safety/Function Switch back **down** to the bottom position to turn off the light.

TESTING THE STUN GUN

(WARNING: Do not test fire the stun gun for more than 1 second as this will damage the unit and void the warranty.)

- 1. Slide the Safety/Function Switch (#7) (located on the side of the unit) **up** to the **top** position. The Stun Warning Light (#8) will illuminate red
- Press the Stun Trigger (#5) (located on the side of the unit) to test the stun gun. You will see and hear an electrical charge fire across the top of the unit between the Stun Test Probes (#3). When test firing the unit, do not hold the button down for more than 1 second
- 3. Slide the Safety/Function Switch back **down** to the bottom position to turn the safety back on.

USING THE ALARM

Slide the Safety/Function Switch located on the side of the unit up to the **middle** position. Press and the Stun Trigger (#5) while to sound the alarm. Releasing the trigger or sliding the switch back to the bottom position will turn the alarm off.

USING THIS PRODUCT IN SELF DEFENSE

- 1. When carrying this unit, we recommend first sliding your hand through the Wrist Strap.
- 2. At night the flashlight can be used to shine in the direction of anyone you think might be a
- If the person continues approaching and you feel threatened, you can sound the alarm to summon help and scare away the threat.
- 4. If you need to use the stun gun to protect yourself, slide the Safety/Function Switch to the top position. Touch your assailant's body with the Contact Probes and press the Stun Trigger.
- Touching anywhere on the assailant's body will have an effect; however, the maximum effect is achieved in the areas shown to the right:
- 6. When touching the assailant's body, you will not see or hear the electrical charge as you do when the unit is test fired. You can hold down the Stun trigger for more than 1 second, as this will not damage the unit, as it will when being test fired.
- 7. You do not have to be concerned about the effects of the charge being transferred to you. Even if the assailant touches you while being stunned, you will not feel the effects of the charge.

EFFECTS OF THE UNIT ON AN ASSAILANT

- 1. Touching an assailant for less than 1 second will cause minor muscle contractions and have a repelling effect.
- 2. Touching an assailant for 1 to 2 seconds will cause muscle spasms and a dazed mental state.
- Touching an assailant for 3 to 5 seconds will cause loss of balance and muscle control, total mental confusion, and disorientation. All effects to the assailant are temporary; the stun gun can cause no permanent harm. (NOTE: The device should not be used for longer than 5 seconds.)

WARRANTY

The lifetime warranty that covers defects in materials or workmanship, with the following exceptions:

- The warranty does not cover damage resulting from accident, misuse or abuse, lack of reasonable care, water damage
 or excessive moisture, the affixing of any attachment not provided with the product, loss of parts, or recharging the unit
 in any manner not in accordance with the included instructions.
- The warranty will be voided if the unit has been opened or tampered with in any way or if any unauthorized replacement
 parts have been used.
- The warranty does not cover the charging cord, wrist strap, or any other accessories.
- Not following the charging instructions shown above voids the warranty.

NOTICE

Purchaser must check and abide by all local laws governing the possession and use of stun guns. In addition, the stun gun must only be used in a lawful manner for self-defense. NOTE: Not to be used on children, persons with heart disease, or any vital part of the human body. Not to be stored in environments where it is damp or humid or where there are extremely hot or cold temperatures. Do not use on metal objects.
